The offer of an advantage, benefit or other inducement by any person with a view to influencing the placing of the Contract may be an offence under the Prevention of Bribery Ordinance (Cap. 201 of the Laws of Hong Kong) but in any event such action will result in the termination of the Contract.
This Contract comprises the entire agreement between the parties to the exclusion of all other terms and conditions and prior or collateral agreements, notices of intention and representations and the parties agree that they have not been induced to enter into the Contract on the basis of any other representation verbal or otherwise.
This Agreement is subject to the laws of the Hong Kong Special Administrative Region of the People's Republic of China ("Hong Kong SAR") and both parties agree to submit to the jurisdiction of and be bound by the Hong Kong SAR courts should any dispute occur.

- Opening hours of gym and pool is subject to change at the discretion of the management.
- Upon successful enrolment, membership fees are neither refundable nor transferable.
- Fitness Centre members are required to present their membership card for using the facilities.
- For any loss of membership cards, HK\$50 charge will be posted to the members' account.
- Members can bring a maximum of two guests at any one time, subject to availability and prior booking is required, and a day charge of HK\$200 per guest (Monday-Friday), HK\$300 per guest (Saturday, Sunday, Public Holiday) will apply.
- A day charge of HK\$300 per guest (Monday-Friday), HK\$400 per guest (Saturday, Sunday, Public Holiday) will apply for non-member's access to Gym and Swimming Pool.
- A monthly membership surcharge of HK\$1,000 (Gym and Pool) and HK\$1,500 (Pool only) per month per person will apply from June to August.
- Fitness Centre members are required to settle total membership fee in advance in one instalment upon successful enrolment.
- Fitness Centre is a non-smoking area and food is not allowed within the Fitness Centre's premises.
- For personal safety reasons, persons under the influence of drugs or alcohol are not allowed to use any of the Fitness Centre or swimming pool facilities.
- For any lost or damaged locker keys, a HK\$140 replacement charge will be imposed.
- Proper sports attire and sportswear must be worn while exercising within the premises of the Fitness Centre.
- All members are required to update Fitness Centre on any change of personal information on a regular basis.
- Rates are subject to change without prior notice.
- The Management of the Harbour Grand Hong Kong Fitness Centre reserves the right to cancel any membership without prior notice.
- The Management of the Harbour Grand Hong Kong Fitness Centre reserves the right to change Rules and Regulations without prior notice and reserves the right to determine whether application for membership is successful or not.
